## Welcome

As we come together during the 38th Australian Dental Congress in Adelaide we also celebrate the 38th year since the Academy was established in Australia and New Zealand. The Pierre Fauchard Academy comprises more than 11,000 Fellows divided into 142 sections, 55 in the United States and another 87 in many other parts of the world, including South America, Europe, Asia, Africa and Australia.

The Pierre Fauchard Academy is an honorary dental service organisation that was founded in 1936 by Dr Elmer S. Best, a Minnesota dentist. One of Dr Best's concerns was a dental press controlled by commercial interests. He wanted the profession to control its own literature. This focus attracted like minds, dental researchers and teachers to its ranks, and led to a continuing role for the Academy in fostering dental science.

The Academy has its own publication program with Dental World and Dental Abstracts, and has always encouraged its Fellows to contribute to dental education and dental literature. Through its Foundation, it offers financial support to various dental projects that increase access to care for underserved populations and provides scholarships to dental students.

The Academy is named after Pierre Fauchard of France (1678-1761), who is recognised as the "Father of Modern Dentistry". Publication of his treatise "Le Chirurgien Dentiste au Traite des Dents" in 1746 is credited with establishing the practice of dentistry as a profession. It was the first textbook for dentists and contained truly remarkable insights into the nature of dental disease. The title page explained that the book will "(teach) the means to maintain teeth in a clean and healthy way, to embellish them, to repair loss and to remedy their diseases, with observations and reflections on several singular cases". Pierre Fauchard and his work remains a worthy example for the Academy in 2019. Interestingly, it was the subject of extensive peer review featuring 19 of his peers, highly prominent members of society and the medical profession, pre-eminent scholars in the fields of science and healing.

The tradition of the Academy reflects the unselfish nature of the publication by Fauchard of what were formerly regarded as trade secrets, free for all to use in assisting humanity. The Constitution of the Pierre Fauchard Academy lays out objectives that honour Dr Best's focus on integrity and ethics.

We now expect you, as Fellows in the Pierre Fauchard Academy, to embrace those objectives.

The Academy selects Fellows who we believe we will bring credit to Dentistry. We seek excellence amongst the criteria considered in recruiting new Fellows.

You few have been selected from many.

The Academy provides you with recognition for your progress within the profession. As we gather here today, we support and honour you, our colleagues, for the distinguished work within your own practices, in research contributions, and public service, by providing distinction in education, and leadership in oral health care. In return we ask that PFA Fellows become role models for the advancement of dentistry to the highest level. Fellowship in the Academy is by nomination and is granted to honour past accomplishments in the field of dentistry but also to encourage future leadership.

Above all else, it is our hope that you will recognise and grow leaders in your profession, your communities and in our society. The Academy Membership are dentists who are among the most outstanding leaders in various fields of dentistry, and we congratulate all new Fellows.

On behalf of the Region 8 Board, thank you for joining with us in welcoming the new Fellows during their Induction Ceremony.

First edition of Fauchard's pioneering work in the field of modern dentistry. Fauchard's *Le chirurgien dentiste* was the first work on the subject to synthesise the theoretical and practical knowledge of dentistry available to him at the time. In the first volume, Fauchard gave a good description of the anatomy of the teeth, set forth rules for their cleaning and preservation, commented that neglect of the teeth is the chief cause of their decay, and devoted a chapter to tartar. He classified dental maladies into three groups and identified more than one hundred morbid conditions. As a result of Fauchard's comprehensive treatment of his subject, his book became the first worthwile textbook of dentistry.
